Above adjustments (+/-) shall be reflected in the subsequent invoice by way of charge or credit.
- The manner of working of incentive and demurrage charges may change from time to time, without any prior notice.
- Goods will be confirmed only in the registered name. Changes in exporters name/address will attract extra charges.
- Payments will be made from the same account which is mentioned in this form.
- Any Short / Excess Payments will be adjusted against the next invoice.
